

CLASSIC AUTO SHOW JUDGES FREQUENTLY ASKED QUESTIONS

WHERE DO THE JUDGES MEET TO RECEIVE THEIR JUDGING FORMS AND INSTRUCTIONS?

THE ARTHRITIS FOUNDATION SPONSORS A DELICIOUS LUNCHEON FOR ALL OF ITS JUDGES AT THE CROWNE PLAZA BALLROOM. THERE WILL BE A SIGN IN THE CROWNE PLAZA'S LOBBY DIRECTING YOU TO THE LOCATION OF THE JUDGES' LUNCHEON WHICH TAKES PLACE AT 11:30 AM.

WHERE DOES EACH JUDGING TEAM RETURN THE JUDGING SUMMARY SHEET AFTER THEY COMPLETE THEIR JUDGING?

ONE REPRESENTATIVE FROM EACH JUDGING TEAM SHOULD RETURN THE JUDGING SUMMARY SHEET TO THE BALLROOM AT THE HILTON GARDEN INN. ONLY THE JUDGING SUMMARY SHEET NEEDS TO BE TURNED IN.

HOW ARE THE WINNERS NOTIFIED SO THEY CAN LINE-UP FOR THE WINNERS PARADE OR CLAIM THE AWARD THEY WON?

EACH JUDGING TEAM WILL HAVE A JUDGING SUMMARY SHEET LISTING ALL OF THE CARS REGISTERED FOR THAT CLASS, A BLUE FIRST PLACE RIBBON, A PARADE POSITION CARD AND CARDS FOR THE AWARD OF EXCELLENCE RECIPIENTS. AFTER ALL OF THE VEHICLES IN THE CLASS HAVE BEEN JUDGED, THE JUDGING TEAM WILL DETERMINE THE AWARD RECIPIENTS. BEFORE LEAVING THE SHOW FIELD, THE JUDGING TEAM WILL GIVE THE FIRST PLACE WINNER (OR BEST OF SHOW WINNER IN SWAS CLASSES) THE BLUE RIBBON AND PARADE POSITION CARD AND THE AWARD OF EXCELLENCE WINNERS THEIR CARDS TO PICK UP THEIR AWARDS. THE JUDGING TEAM NEEDS TO MARK THE CARDS WITH THE AWARD (1ST PLACE OR A OF E) CLASS #, CAR #, AND OWNER'S NAME. ONE REPRESENTATIVE FROM EACH JUDGING TEAM WILL RETURN THE COMPLETED JUDGING SUMMARY SHEET SHOWING THE WINNERS TO THE JUDGING ROOM.

HOW DOES EACH PARTICIPANT KNOW THEIR CAR HAS BEEN JUDGED?

AFTER YOUR TEAM JUDGES A VEHICLE, A SMALL STICKER MUST BE AFFIXED TO THE VEHICLE'S REGISTRATION CARD.

WHO FILLS OUT THE JUDGING FORMS?

ANY TEAM MEMBER CAN RECORD THE JUDGING RESULTS ON THE JUDGING SUMMARY SHEET AS EACH PARTICIPANT'S AUTOMOBILE IS JUDGED.

CAN I ASK A PARTICIPANT TO OPEN THEIR AUTOMOBILE'S DOORS, TRUNK, HOOD, ETC?

IF THE PARTICIPANT IS PRESENT, YOU SHOULD FEEL FREE TO ASK THEM TO OPEN ANY OF THEIR AUTOMOBILE'S COMPARTMENTS. PLEASE DO NOT TOUCH ANY PARTICIPANT'S AUTOMOBILE. PLEASE DO NOT DISCUSS JUDGING RESULTS WITH ANY PARTICIPANT. THERE WILL BE A HEAD JUDGE AVAILABLE TO ADDRESS ANY PARTICIPANT'S CONCERNS.

WHAT DO I DO IF THE HOOD OR TRUNK IS CLOSED?

IF THE HOOD OR TRUNK IS CLOSED, IF A CONVERTIBLE TOP IS DOWN AND CAN NOT BE SEEN OR IF THERE IS ANY AREA OF THE CAR THAT CAN NOT BE JUDGED, THE MAXIMUM AMOUNT OF POINTS FOR THAT ITEM IS DEDUCTED. FOR EXAMPLE, IF THE ENGINE COMPARTMENT CAN NOT BE JUDGED BECAUSE THE HOOD IS CLOSED, 15 POINTS WOULD BE DEDUCTED.

HOW WILL THE SHOW'S PARTICIPANTS KNOW I AM A JUDGE?

AT THE JUDGE'S LUNCHEON, YOU WILL BE GIVEN A T-SHIRT THAT CLEARLY INDICATES YOU ARE A JUDGE.
